OUR RESPONSIBILITY: Well owners in Blanco County are required by State Law to notify our District when there is a change in well ownership, condition, operation, status or nature of use (e.g., from domestic to commercial or large pumping volume). Read the "Rules" section of our website, or check with our office for precise definition.

"NOT NEW" BOARD DIRECTOR: A new - but not new - Board Director is back with us. At our April 25 Board meeting, James Sultemeier was appointed to fill our vacant Precinct 2 position. He is a local-local, and was one of our first Board of Directors back in 2002. He is a retired County Commissioner and has served in many capacities in Johnson City and Blanco County. BPGCD BOARD RESOLVES CONTINUES OF LEVEL 4 DROUGHT RESTRICTIONS IN BLANCO COUNTY

At their monthly meeting on May 16, 2024, the board of Directors of the Blanco-Pedernales Groundwater Conservation District heard reports by consulting geologist Ron Fieseler and BPGCD General Manager George Cofran on the water level test results obtained from many of the County's 27 test wells.

A few wells tested since mid-April showed significant water level increases, but many more produced static results or decreases, even in the wake of the county's recent Spring rainstorms.

Blanco County drought restrictions have been at Level 4, the highest level of wateruse curtailment, since August of 2023. Considering recent groundwater level measurements at the test wells, the Board of Directors voted to leave drought restrictions at Level 4.

WELL INSPECTION VOLUNTEERS ATTEND TRAINING DAY

BPGCD consulting geologist Ron Fieseler conducted a training day for well inspection volunteers on May 8. Volunteers attended classroom instruction in the

District offices, then went out to a local property, where 3 wells of different types provided a range of inspection testing examples.





WELL INSPECTION PROGRAM: We have launched the next phase of our field services program focused on inspecting wells. We prepared classroom materials and held a live training session with inspection of four wells. Ron Fieseler, PG, taught the course, including classroom presentations and field experiences. Volunteer Scott Courtney, PG, assisted in the development of our training materials. Scott and our inspectors are volunteers, as are those folks serving on our well monitoring team.

VOLUNTEERING: If any of this sparks an interest, please don't hesitate to contact George or Erik to explore your volunteer interests. Whether it is field work or inoffice data work regarding our well records and processing of same, or computer work, or special projects and studies. Just give us a hint and we will help you explore options.

SOIL & WATER CONSERVATION PROGRAM PRESENTATION: Our Director, George Cofran, participated in the annual field day event on 4/30 held by Pedernales Soil & Water Conservation, and provided an update on "what's happening" with drought, groundwater, rules, and answered lots of questions.

OFFICE UPDATES:

We have acquired several "All-In-One" computers to support our growing staff.

We can now process your payment checks electronically right from our office using our new internet connected check reader device from our bank. Easy peasy.
