## ADOPTION OF AD VALOREM TAX RATE AND FEE SCHEDULE FOR FY 2025 (TAX YEAR 2024)

WHEREAS, the Blanco-Pedernales Groundwater Conservation District (BPGCD) is a groundwater conservation district created in accordance with and subject to Chapter 36, Water Code; and

WHEREAS, the BPGCD has the authority under Chapter 36, Water Code, and the District Enabling Documents to set and collect Ad Valorem taxes not to exceed \$0.05 per \$100 valuation, and to set; and

WHEREAS, on August 25, 2024, in a properly posted open meeting, the Board of Directors proposed an Ad Valorem tax rate for FY 2025 (Tax Year 2024) of \$0.017327 per \$100 valuation and has proposed a Fee Schedule for FY 2025; and

WHEREAS, the Board of Directors, provided notice to the public of a public hearing on September 19, 2024, on the proposed Ad Valorem Tax Rate by posting notice in the August 21, 2024, editions of the Johnson City Record Courier and the Blanco County News, on the District website, and on the front door of the District Office; and

WHEREAS, the Board of Directors held a public hearing on September 14, 2024, to receive and consider all public comment; and

WHEREAS, following the public hearing, the Board of Directors of the BPGCD voted to set the FY 2025 (Tax Year 2024) Ad Valorem tax rate at \$0.016671 per \$100 valuation.

NOW THEREFORE BE IT RESOLVED, that the Board of Directors of the Blanco-Pedernales Groundwater Conservation District does hereby approve this Resolution incorporating the Board's adoption of the FY 2025 (Tax Year 2024) Ad Valorem tax rate of \$0.016671 per \$100 valuation. THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

BE IT FURTHER RESOLVED that the Ad Valorem tax rate herein adopted shall have an effective date of October 1, 2024.
